Corporate Members

For the purpose of this class of membership, "Corporation" means a company incorporated and validly existing under the laws of the Province of British Columbia or the laws of Canada, as the case may be.

This class of membership consists of any Corporation:

- (i) Which has paid or agreed to pay the required entrance fee or annual fee as set by the Board from time to time (and remains current in all payments due in respect thereof);
- (ii) Which has acquired or agreed to acquire five (5) Class B shares of the Company;
- (iii) Which has nominated one (1) Adult Person (the "Nominee") to enjoy the rights and privileges and observe the restrictions of this class of membership; and
- (iv) Whose Nominee has satisfied the requirements for election to membership set out in Bylaw 2 of the Bylaws of the Society (it being understood that it is the Corporation and not the Nominee who will actually become the member of this class of membership).

The total number of Corporate Members shall be set by the Board from time to time but shall not exceed twenty (20) per eighteen holes of golf course playable.";

Corporate Members

This class of membership is entitled to all privileges of the Club. Each Corporate Member has the right to change its choice of Nominee upon:

- (i) Making written application to the Board to change its Nominee;
- (ii) Such new Nominee satisfying the requirements for election to membership set out in Bylaw 2 of the Bylaws of the Society as contemplated by Bylaw 1(o)(iv); and
- (iii) Upon payment by that Corporate Member of a transfer fee to be determined by the Board at their discretion.

Subject to the restrictions contained the Bylaws, the Nominee of a Corporate Member shall be entitled to vote at any meeting of the Club. No Corporate Member nor any Nominee of a Corporate Member is permitted to become an officer or director of the Club at any time.

Any Nominee is entitled to transfer to the Full Play Members class or to the Associate Members class in his or her own right, subject to there being vacancies available in that class of membership, upon payment of a transfer fee determined by the Board at their discretion, and provided that such Nominee and the Corporate Member who nominated such Nominee are in good standing at the time of such transfer. The transfer fee shall be a percentage of the current applicable entrance fee for the class of membership to which the Nominee is transferring.
